**NSCD Celebrates 50th Anniversary of Wells Fargo Ski Cup
During Winter Paralympic Year**

DENVER (Feb. 4, 2026) – The National Sports Center for the Disabled (NSCD), one of the nation's leading providers of adaptive outdoor recreation, is pleased to announce this year kicks off their **50th Annual Wells Fargo Ski Cup**, taking place **February 19–21, 2026** at Winter Park Resort. This milestone year coincides with the 2026 Winter Paralympics, making the event a powerful celebration of inclusion, athletic excellence and legacy.

"Celebrating 50 years of the Wells Fargo Ski Cup during a Winter Paralympic year is incredibly meaningful. This event reflects the power of sport to unite communities, elevate athletes of all abilities and inspire future generations. This year's Wells Fargo Ski Cup features a standout lineup of events, including a rare opportunity for the public to watch Winter Paralympic hopefuls compete in the World Disabled Invitational before they depart for Italy. Before the races on Friday morning, February 20th, Wells Fargo will celebrate 50 years of the Wells Fargo Ski Cup by presenting the NSCD with a \$50,000 grant and will team up with Colorado's Front Range Toyota Stores to present the organization with a 2026 Toyota Tundra to help the organization continue to carry out its mission.

Thursday, Feb. 19

- 9:30–11:00 a.m.: World Disabled Invitational, presented by Toyota. Professional adaptive athletes from around the world compete in a race unlike any other.
- 3:00–4:00 p.m.: AEC Challenge is a race between architects, engineers and contractors who race for industry bragging rights and the coveted Outrigger Trophy.
- 6:00 - 9:00 p.m.: Disco at the Base is a 1976-themed après-ski party with live music from The Boogie Machine, drinks, appetizers and retro outfits.

Friday, Feb. 20

- 10:30 a.m.: Wells Fargo will present NSCD with a \$50,000 check and will join Front Range Toyota Stores to present NSCD with the keys to a new 2026 Toyota Tundra during special key ceremony.
- 11:30 a.m.–3:00 p.m.: Corporate Challenge includes skiers and snowboarders from corporate teams racing alongside NSCD Competition Center athletes training for the Winter Paralympics.
- 11:00–11:30 a.m.: Kids Snowplow Sprint is sponsored by HPM Contracting. Young adventurers tackle the same course as the pros.
- 7:00 - 10:00 p.m.: Snow Boot Soiree is presented by Rendezvous Colorado. It's an evening celebration at Headwaters Center with dinner, cocktails, guest speakers and a paddle raise. Invitation only.

Saturday, Feb. 21

- Complimentary Ski Day: Attendees hit the slopes with family, friends and fellow racers. Ongoing weekend features include a silent auction, raffles, VIP & hospitality tents, and more.
